## General Information

---

1. Each new family will create a family account at [www.shopwithscrip.com](http://www.shopwithscrip.com).
2. Families already enrolled in the program must update their contact information at [www.shopwithscrip.com](http://www.shopwithscrip.com) including their child's current teacher.
3. All Scrip gift card orders not paid by PrestoPay must be accompanied by a check or money order made payable to St. Therese School. Payments must be made immediately. Cash will not be accepted for Scrip card purchases. Weekly orders must be sent to school in the plastic Scrip envelope provided by your SC.
4. Please refer to the monthly Scrip calendar or Summer calendar on the Friday Folder for purchasing dates.
5. Scrip gift cards are purchased on your behalf and are not returnable.
6. When you receive your Scrip order, please open the order and verify for accuracy within 24 hours. Please contact your SC with any discrepancies ASAP.
7. Scrip cards are the same as cash and should be handled accordingly. STS will not be responsible for cards that are lost, stolen or misplaced while in your possession.
8. You must sign this form accepting these terms before Scrip cards will be issued. These forms will be kept on file with your SC.

## Financial Commitment and Rebates

---

1. The Scrip program is an unlimited cash back program. Each family is required to participate in the Scrip program. To ensure full participation in the program, a \$25 fee will be added to each of your ten monthly tuition payments (or \$250 if paid in full).
2. Any Scrip cards purchased will be paid for by the purchasing family. This is in addition to the \$250 Scrip Fee. The \$250 Scrip Fee is not used to purchase cards for your family.
3. At the end of the Scrip year (May 31, 2019), you will receive a check back in the amount equal to 75% of the rebates earned through the purchase of the Scrip cards that your family purchased. Rebate percentages vary and are set by the GLSC. Please refer to [www.shopwithscrip.com](http://www.shopwithscrip.com) for rebate percentages for each card type.
4. Rebate Checks will only be issued to those families whose tuition account is current and have fulfilled all other obligations under the tuition contract (50/50 Raffle, Bingo, Tricky Tray, Volunteer Requirements, etc.).
5. Rebate Checks will be mailed by the end of June 2019 for this Scrip purchasing year.
